Jammu, the 5th of March, 2012


SRO 80 .- Whereas, the Government of Jammu and Kashmir, in consultation with the Employees State Insurance Corporation and with the approval of the Central Government, notified its intention to extend the provisions of the Employees State Insurance Act, 1948 (Central Act No. 34 of 1948) to other classes of establishments as per the details given in "Annexure" to this notification; and

Whereas, the intended extension was notified by the State Government vide notification SRO 104 of 2011 dated: 28-03-2011, for information of the general public and for inviting the objections / suggestions if any to be submitted within a period of six months from the date of publication of said notification; and

Whereas, no objections or suggestions have been received by the Government in this regard.

Now, therefore, in exercise of the powers conferred by sub-section (5) of Section 1 of the Employees State Insurance Act, 1948, (Central Act No. 34 of 1948), the State Government in consultation with the Employees State Insurance Corporation and after approval of Government of India hereby extend the provisions of the said Act to other classes of establishment as per the details given in "Annexure" to this notification.



Annexure to Notification SRO 90 Dated: 8-3-2012

Description of Classes of establishments

Any of the following classes of establishments situated in any area of the State where Employees State Insurance Act, 1948 is in force and wherein ten or more persons are employed, or were employed on any day of the proceeding twelve months, namely:-

- i) Shops;
- ii) Hotels;
- iii) Restaurants;
- iv) Road Motor Transport establishments;
- v) Cinemas including preview theatres;
- vi) News paper establishments as defined in section 2 (d) of the Working Journalists (Conditions of Service) and Miscellaneous Provisions Act, 1955 (45 of 1955);
- vii) Educational Institutions (including public, private, aided or partially aided), run by individuals, trustees, societies or other organizations;
- viii) Medical Institutions (including corporate, joint sector, trust, charitable and private ownership hospitals, nursing homes, diagnostic centres, pathological labs).
