<u>ORDER</u>

Payment of wages to employees/labourers by Industries, Builders, Hoteliers, Contractors, Shop & Other commercial establishment owners in the U.T. of Dadra and Nagar Haveli and Daman and Diu

In pursuance of the directions NO.40-3/2020-DM-I (A), Dated 29-03-2020 issued by Ministry of Home Affairs, Govt. of India, it has been strictly directed that –

"All the employers, be it in the Industry or in the shops and commercial establishments, shall make payment of wages of their workers, at their work places, on the due date, without any deduction, for the period their establishment are under closure during the lockdown."

In continuation of the above order, all the Industries, Builders, Hoteliers, Contractors, Shop & Other commercial establishment owners in the U.T. of Dadra and Nagar Haveli and Daman and Diu are hereby directed to strictly ensure following points -

- Payment of wages to every employed person (whether regular, contractual, daily wages) as per the provision laid down under the Payment of Wages Act, 1936.
- No reduction of wages shall be made from the salary/wages of the employed person.
- No deduction shall be made from the salary/wages of the employed person.
- No employed person shall be terminated/suspended from their duty during the lock down period declared by the Government of India.
- The above directives shall be followed scrupulously failing which action shall be taken against the errant company under the relevant provision of the Labour Laws.

All Industries, Builders, Hoteliers, Contractors, Shop & Other commercial establishment owners in the U.T. of Dadra and Nagar Haveli and Daman and Diu shall also give a signed undertaking in the enclosed Annexure to the concerned Labour Department through email
