In exercise of the powers conferred by the Delhi Epidemic Diseases, COVID-19. Regulations, 2020 under the Epidemic Diseases Act, 1897, the following directions are hereby issued for the purpose of prevention and control of the outbreak of epidemic disease namely COVID-19 in NCT of Delhi, with immediate effect : -

The operations of all Gymnasium and SPA in NCT of Delhi to be suspended till (0) 31st March, 2020.

The operations of all Night Clubs and Theaters in NCT of Delhi to be suspended (ii)till 31th March, 2020.

The operations of all Weekly Bazar in NCT of Delhi to be suspended till 31st (iii) March, 2020.

Social/Cultural/Political/Religious/Academic/Sports/Seminar/ gathering (iv) Conference and Family mass gathering (except marriages) is restricted to maximum of 50 persons in NCT of Deihi till 31st March, 2020.

All Shopping Malls in NCT of Delhi should be disinfected daily and shall also (v) make provisions of availability of ample number of hand sanitizers at main entrance and individual shops for visitors. All entry should be allowed only after cleaning of hands with hand sanitizers.
