As you may be aware, transactions through digital mode, bank transfers / e-transfers (including e-wallat) have tremendous benefits in terms of speed, economy in expenditure, accountability, security and transparency.

- 2. As of now most of the transactions in Central Government take place through banks transfers / cheques / PFMS. With the introduction of new technology such as e-payments, e-wallet, NEFT/RTGS etc. it is desirable that the remaining cash transactions if any in any form, should also be made only through banks / electronic modes paving way for cashless and digital economy.
- 3. Accordingly, I would request all the Heads of the Organizations to ensure that no transaction whatsoever take places in cash and modern approved electronic modes are resorted to for making and receiving the govt. payments. A confirmation may be submitted to Shri R.K. Gupta, JS(Admn) that you have reviewed your organisation's existing system of making / receiving the government payments and it has been ensured that all transactions are taking place through electronic and digital modes.

Sub: PAYMENT OF BILLS / CLAIMS THROUGH ELECTRONIC CLEARING SYSTEM

Sir.

Attention is invited on Hqrs letter no. F-27/26/ECW/1/11-A/cs. III dated 01/03/2011 and Benefit Branch letter dated 14/11/2011 which is already available on ESIC website in circulars section at sl no. 111/2011 and 618/2011 respectively. It was clearly instructed that all payment to beneficiaries and third parties is to be done through Electronic Clearing System (ECS) only. In spite of these instructions, it is reported that payments are being made through cheques also which is defiance of Hqrs instruction and defeats the dual purpose of ease in settlement of claims and safety in transaction.

As such, in order ensure compliance of ibid instructions and safety in payment the following must be followed while making payment and after payment:-

- 1) All payments must be made through electronic mode i.e. Bank Transfer (BT), ECS, NEFT or RTGS only. Facility for payment of electricity, telephone bills, state taxes etc through electronic mode is also available which should be explored. Cheque should be issued only in cases where payment through electronic mode is not possible.
- 2) BT/ECS/NEFT/RTGS mandate should be prepared very carefully and each and every entry must be checked by the dealing assistant, superintendent and the Asstt Director (F)/Dy Director (F) /Joint Director (F) and signed the printout of mandate in token of checking.
- After making payment, one copy of mandate as mentioned in para 3 above should be forwarded to DDO also for their cross verification and record.

Strict compliance of above instruction is requested.
