- Educational Institutions (including public, private, aided or partially aided), run by individuals, trustees, societies or other viil organizations;
- Medical Institutions (including corporate, joint sector, trust, charitable and private ownership hospitals, nursing homes, viii) diagnostic centres, pathological labs).
